A. Not generating Awareness Regarding Job Duties and Methodologies



- 19. Creating an amiable and pleasant environment within and outside the homes.
- 20. Leading to up-gradation of overall standards of living.

V. CONCLUSION

Criminal and violent acts are prevalent in all communities throughout the country. Effects of criminal and violent acts are, leading to a decline in motivation levels; being overwhelmed by dilemmas and challenging situations; staying in seclusion; not generating awareness regarding job duties and methodologies; experiencing health problems and illnesses and being overwhelmed by psychological problems. Measures to be implemented in curbing criminal and violent acts are, considering girls equal to male counterparts, providing them equal rights and opportunities, implementing effective communication processes, providing solutions to problems, treating girls with respect and courtesy, providing them education, encouraging participation in various activities, promoting empowerment opportunities, allowing them to make own decisions, promoting health and wellbeing, leading to up-gradation of their personality traits and creating an amiable environment. Furthermore, one needs to understand consequences of curbing criminal and violent acts. Finally, it can be stated, curbing criminal and violent acts reinforces well-being and goodwill.
